

## **Town and Country Planning Act 1990**

Tree Preservation Order (TPO) Title: **Oakmoor Place (EH1235)2025**

The East Hampshire District Council, in exercise of the powers conferred on them by section 198 of the Town and Country Planning Act 1990 make the following Order—

### **Citation**

1. This Order may be cited as **Oakmoor Place (EH1235)2025**

### **Interpretation**

2. (1) In this Order “the authority” means the EAST HAMPSHIRE DISTRICT COUNCIL.  
(2) In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation) (England) Regulations 2012.

### **Effect**

3. (1) Subject to article 4, this Order takes effect provisionally on the date on which it is made.  
(2) Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—  
(a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or  
(b) cause or permit the cutting down, topping, lopping, wilful damage or wilful destruction of,  
  
any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

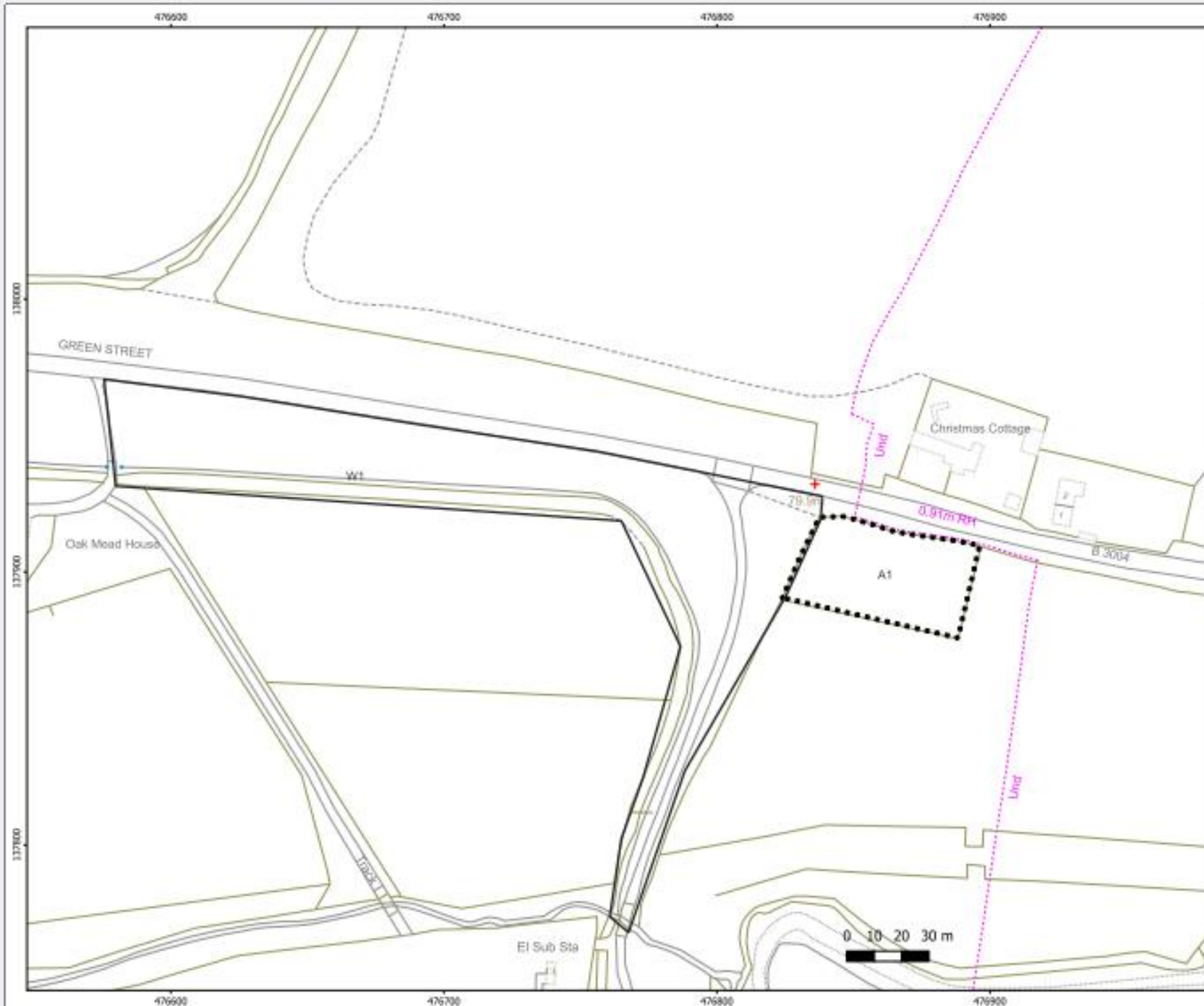
## SCHEDULE: Specification of trees

<i>Reference on map</i>	<i>Description</i>	<i>Situation</i>
<b>A1</b>	<b>Trees (of whatever species) within the area marked A1 on the map</b>	<b>Located to the east of the woodland identified on the plan as W1, southeast of the road junction, and directly south across Green Street from Christmas Cottage</b>

### Woodlands (within a continuous black line on the map)

<i>Reference on map</i>	<i>Description</i>	<i>Situation</i>
<b>W1</b>	<b>Mostly deciduous consisting in the main of English Oak and scrub understorey</b>	<b>Woodland edge adjacent to Green Street (B3004) and west of the country lane junction.</b>
